**PLAINTIFFS' NOTICE OF UNOPPOSED MOTION FOR PRELIMINARY APPROVAL
OF CLASS SETTLEMENT**

PLEASE TAKE NOTICE, that upon the accompanying Memorandum of Law in support of Plaintiffs' Unopposed Motion for Preliminary Approval of Class Settlement, together with Exhibits 1 and 2 thereto, and upon all of the pleadings and proceedings herein, Plaintiffs, by their undersigned attorneys, will move this Supreme Court of the State of New York, Monroe County, located at 99 Exchange Boulevard, Rochester, New York 14614, on the **13th day of January**, at 9:30 a.m. in the forenoon of that date, or as soon thereafter as counsel may be heard, for an Order to be entered for the following relief: (1) granting preliminary approval of the settlement described in the "Settlement Agreement" between Plaintiffs and PMC as within range of possible final approval as fair, reasonable, and adequate; (2) preliminarily certifying the Settlement Class for purposes of Settlement; (3) appointing Plaintiffs Cory Rehmsmeyer and Toni Hyde as Class Representatives; (4) appointing CohenMalad, LLP and Milberg, PLLC as Class Counsel; (5) approving the notice plan set forth in the Settlement Agreement; (6) appointing Angeion Group ("Angeion") as Settlement Administrator; (7) approving the form and content of the Short Form Notice (S.A. Ex. 1 and 2), Long Form Notice (S.A. Ex. 3), and Claim Form (S.A. Ex. 4); and (8)

scheduling a Final Fairness Hearing to consider entry of a final order approving the Settlement, final certification of the Settlement Class for settlement purposes only, and the request for attorneys' fees, costs, and expenses, and Plaintiffs' service awards.
